Terms and Conditions for the MIB9 Promotion

These Terms and Conditions (“Terms”) apply to the MIB9 Promotion (“Promotion”) conducted by Maldives Islamic Bank Plc (“the Bank”). By participating, entrants accept and are bound by these Terms, as well as any amendments thereto.

1. Promotion Duration and Eligibility Criteria

- a. The Promotion is valid from July 1, 2025, through October 15, 2025 (inclusive).
- b. Eligibility is restricted to new MIB9 members who commence salary crediting to a Maldives Islamic Bank account within the Promotion Period and maintain active membership status at the time of the draw.
- c. Individuals who were MIB9 members prior to July 1, 2025, and all employees of Maldives Islamic Bank, are ineligible for participation.

2. Entry Mechanism

- a. Qualified members are automatically entered into the lucky draw; no additional registration procedure is required.
- b. Each qualified member is granted one entry only, irrespective of differing account types or salary amounts.

3. Prizes Details

- a. Prizes awarded include:

Two round-trip tickets on Batik Air to one of its international destinations or a travel voucher of equivalent value.

A complimentary one-year gym membership at either TFG or Gymnasia, with a cap of MVR 13,000.

A \$1,000 cash prize to be deposited directly into the winner's MIB account.

- b. Prizes are strictly non-transferable and non-substitutable, except under circumstances deemed reasonable by the Bank.

4. Drawing and Winner Notification

- a. The selection of winners will occur in November 2025 through a randomized process, publicly announced via the Bank’s official social media platforms.
- b. Winners will be notified using the contact information registered with the Bank.

5. Prize Redemption and Usage

- a. Gym membership prizes must be activated within two months following the announcement, at a gym pre-approved by the Bank, remaining valid for one year from activation.
- b. Airline ticket awards must be redeemed within three months post-announcement. Travel arrangements must be finalized within this period, contingent on availability and subject to the airline’s stipulated terms and conditions.

6. Reservation of Rights

- a. The Bank retains exclusive rights to alter, extend, suspend, or discontinue the Promotion, and to replace any prize with another of comparable value without prior notice.

7. Liability Disclaimer

- a. The Bank assumes no liability for lost, delayed, misdirected, or incomplete entries.
- b. Participants agree to indemnify and hold the Bank harmless from any claims or damages resulting from their involvement in the Promotion or their acceptance or use of any prize.

8. Governing Law and Jurisdiction

- a. These Terms shall be governed by and construed in accordance with the laws of Maldives.



b. Any disputes arising out of or concerning these Terms shall be subject to the exclusive jurisdiction of the competent courts of Maldives.
