



Supplementary Terms and Conditions for Save with MIB Campaign – Week 4 Eid Holiday Getaway Reward

These Terms and Conditions (“Terms”) apply specifically to the **Week 4 Eid Holiday Getaway Reward** is a promotion offered under the **Save with MIB Campaign** conducted by Maldives Islamic Bank Plc (“the Bank”).

These Terms shall be read together with the General Terms and Conditions of the Save with MIB Campaign and the Terms and Conditions for MIB Accounts and any and all other relevant Terms and Conditions. Eligibility criteria, entry mechanism, draw process, and winner selection shall remain as stated in the main campaign Terms and Conditions.

For the avoidance of doubt and for all intents and purposes, the Customer shall be deemed to have accepted these terms and conditions set out below and agrees to be bound by them immediately when:

- the Customer successfully completes the application of the Account Opening during the “Save with MIB 2026” Promotion period.

By accepting the Week 4 Eid Holiday Getaway Reward, the winner agrees to be bound by these Terms.

The Publication of the Terms and Conditions (as amended) on the Bank’s website shall be deemed notification of the same to the Customer.

1. Prize Details

a. The “Week 4 Eid Holiday Getaway Reward” (hereinafter referred to as “Reward”) means the **four-night stay at Nest by Hawks Hotel, Baa Kamadhoo, from 26 May 2026 to 30 May 2026, allowed on a full-board basis for two people during the Eid Al-Adha Holidays of 2026.**

b. The Reward includes **return speedboat transfer** for two people.

c. The Reward is arranged specifically for the Eid Al-Adha holidays 2026. Therefore, the travel dates are fixed and cannot be changed, extended, postponed, or shifted to any other dates.

d. Any additional costs not expressly included in the Reward, including but not limited to personal expenses, extra meals or beverages, room upgrades, additional activities, special requests, excess baggage, transfer changes, cancellation fees, no-show charges, or any other incidental expenses, shall be borne by the winner and/or the nominated travellers.



2. Reward Transferability

- a. The prize may be transferred to up to two persons nominated by the winner, subject to the Bank's review and approval.
- b. The winner must submit a formal request via email to deposits@mib.com.mv stating the reason for transferring the prize and providing the details of the nominated travellers.
- c. The Bank reserves the right to validate the reason for the transfer and may request supporting documents or additional information where required.
- d. Approval of any transfer request shall be at the sole discretion of the Bank. The Bank's decision on whether to approve or reject a transfer request shall be final. Approval/ rejection of the transfer request will be communicated via email.
- e. Once the nominated travellers are confirmed and the booking is processed, no further changes to traveller details shall be permitted.
- f. Transfer of the prize does not allow any change to the confirmed travel dates of **26 May 2026 to 30 May 2026**.

3. Reward Redemption and Usage

- a. The winner must confirm acceptance of the prize within the timeframe communicated by the Bank.
- b. The winner must provide all required traveller details, identification documents, and any other information required for booking purposes within the deadline communicated by the Bank.
- c. Failure to provide the required information within the given deadline may result in forfeiture of the prize, without any compensation or replacement.
- d. The prize must be used only during the specified travel period from **26 May 2026 to 30 May 2026**.
- e. The prize cannot be redeemed for cash, exchanged for another reward, carried forward to another date, or used in parts.
- f. The Bank shall not be responsible if the winner or nominated travellers are unable to travel due to personal circumstances, medical reasons, travel restrictions, invalid or insufficient identification documents, failure to meet travel requirements, or any other reason beyond the Bank's control.
- g. The winner and/or nominated travellers shall be responsible for ensuring that they are available to travel on the confirmed dates and comply with all requirements communicated by the Bank, hotel, transfer provider, or any other relevant service provider.

4. Reservation of Rights

- a. The Bank reserves the right to verify the winner's eligibility before awarding the prize.
- b. The Bank may amend, cancel, withdraw, or substitute the prize with another reward of similar value if required due to circumstances beyond the Bank's control.
- c. The Bank shall not be responsible for any changes, delays, cancellations, or service issues caused by the hotel, transfer provider, weather conditions, government authorities, or any third party.
- d. The Bank's decision on all matters relating to the prize shall be final and binding.

5. Liability Disclaimer

- a. The Bank is not responsible for the quality, safety, availability, or performance of services provided by the hotel, transfer provider, or any third party.
- b. The winner and/or nominated travellers shall use the prize at their own risk and are responsible for their own conduct and compliance with applicable rules.
- c. The Bank shall not be liable for any loss, damage, injury, cost, delay, or inconvenience arising from the use or transfer of the prize.
- d. The winner agrees to hold the Bank harmless against any claims or liabilities arising from the acceptance or use of the prize.
